1. TITLE AND COMMENCEMENT

THIS STATUTE SHALL BE CALLED "VIJAYANAGARA SRI KRISHNADEVARAYA UNIVERSITY STATUTE GOVERNING ADVISORY BOARD FOR PRASARANGA AND EXTRAMURAL STUDIES" UNDER SECTION 7 OF KSU ACT, 2000

THIS STATUTE SHALL COME INTO FORCE FROM THE DATE OF THE ASSENT BY THE CHANCELLOR

1. CONSTITUTION

1.1 The Publication Board shall consist of :-

- i) The Vice-Chancellor (Ex-Officio) (Chairperson)
- ii) The Registrar (Adm)
- iii) The Chief Librarian (Ex-Officio) State Library, Bangalore (Ex-Officio Member)
- iv) One member of the Syndicate nominated by the Vice-Chancellor.
- v) One eminent person of letters Nominated by the Vice-Chancellor
- vi) One member of the Academic Council nominated by the Vice-Chancellor
- vii) Director of Prasaraanga (Member- Secretary) Vijayanagara Sri Krishnadevaraya University, Bellary (Ex Officio)
- viii) When a subject expert is required, a P.G. teacher working at least in the cadre of Associate Professor concerned may be invited by the Chairman.
- ix) One Dean to be nominated by the Vice-Chancellor for a period of one year.

1.2 The Member of the Board except ex-officio members shall hold the office for a period of two years. Members nominated from Syndicate and Academic Council shall cease to be the members of the Board on cessation of membership of the Syndicate and Academic Council as the case may be. Any casual vacancy shall be filled for the residuary period of his/her predecessor.


1.3 The Board shall meet twice a year and at other times when convened by the Chairman. Four members shall constitute quorum.


2. POWERS AND FUNCTIONS

2.1 The functions of the Board shall be to advise concerned authorities of the University in respect of following matters.


To undertake the publication of -

- iv. Research works including Doctoral Thesis.
- v. Edited classical works

 - vii. Translations of important Kannada work into other languages and vice-versa.
 - viii. Any other works considered suitable by the Committees.
- 2.2 To constitute additional Committee for the University Journals and Periodicals.
 - 2.3 To recommend to the Syndicate regarding royalty to be paid in respect of publications.
 - 2.4 To recommend to the Syndicate the payment of remuneration for scrutinizing copying etc., of the manuscripts.
 - 2.5 To recommend to the Syndicate the rates of Commission in the sale of University Publications and to take necessary steps from the point of view of sale promotions.
 - 2.6 To recommend to the Syndicate any new schemes regarding Publications.
 - 2.7 To organize extension lecture camps at moffusil places coming under the jurisdiction of the University.
 - 2.8 To organize lecture (Special) Camps at Town places in the University area.
 - 2.9 To arrange special lecture series at the University Centers.
 - 3.10. To organize the Circulation Library Centers in the groups of villages.
 - 3.11 To organize any other cultural functions for the benefit of the common people.


