1. TITLE AND COMMENCEMENT:

i) THIS STATUTE SHALL BE CALLED **VIJAYANAGARA** SRI KRISHNADEVARAYA UNIVERSITY STATUTE GOVERNING THE LIBRARY ADVISORY BOARD UNDER SEC 37 OF KSU ACT, 2000

ii) THIS STATUTE SHAL COME INTO FORCE FROM THE DATE OF THE

ASSENT OF BY THE CHANCELLOR

2. CONSTITUTION:

The Library Advisory Board shall consist of: 2.1

- i) The Vice-Chancellor, (Chairperson)
- ii) The Registrar
- One Member of the Syndicate and one member from Academic iii) Council nominated by the Vice-Chancellor.
- All Deans of the Faculties (Ex-officio) iv)
- The Chairman of the Dept. of Studies in Library and Information $\mathbf{v})$ Science, Vijayanagara Sri Krishnadevarya University, Bellary (Exofficio)
- The Librarian (Member-Secretary) vi)
- The members of the Board shall hold office for two years and may be 2.2 Re-appointed. The office of the member of the Library advisory Board shall be vacated by death, resignation or ceasing to be the members of the Body from which one is nominated.
- The board shall meet twice in a year and at other times when convened by 2.3 the Vice-Chancellor.
- A minimum of Six members shall constitute quorum for the meeting. 2.4

POWERS AND FUNCTIONS

3.1 The Library Advisory Board shall, subject to the control of the Syndicate, manage the Library and advise the Syndicate on any matter connected with the Library referred to it by the Syndicate.

In particular and without prejudice to the generality of the foregoing powers, the Board shall have the authority to make recommendations to the Syndicate for

- i. The allotment of the funds earmarked for the Library.
- All the matters connected or incidental to the Library.

- 3.2 The Board shall report to the Syndicate, for information, the purchase of books and the disposal of such books as in the opinion of the Board are worthless, obsolete or otherwise useless. For this purpose, books shall include manuscripts and periodicals.
- 3.3 The Library Advisory Board shall have the power to make rules governing the use of the Library from time to time and to amend the same and any changes made therein shall be placed before the Syndicate for approval.
- 4. The Advisory Board shall keep an account of all funds provided for the purposes of the Library and forward a statement of such accounts to the Registrar for submission to the Syndicate every three months.
- 5. There shall be a separate account in the Bank under the name "Library Account"
- 6. All bills in respect of books and other materials purchased for the Library shall be verified, checked and signed by the Librarian in attestation of their correctness.

7. All cheques shall be signed by the Finance Officer, after satisfying his self/himself that the amounts entered therein tally with the bills.
