STATUTE RELATING TO THE FUNCTIONS OF COLLEGE DEVELOPMENT COUNCIL AND QUALIFICATIONS, POWERS, DUTIES, EMOLUMENTS, TERMS AND CONDITIONS OF THE DIRECTOR, COLLEGE DEVELOPMENT COUNCIL OF VIJAYANAGARA SRI KRISHNADEVARYA UNIVERSITY, BELLARY FRAMED UNDER SECTION 25 OF KSU ACT 2000.

1. Title and Commencement

This statute may be called "Vijayanagara Sri Krishnadevaraya

University College Development Council Statute 2011."

This statute shall come into force from the date of assent by the Chancellor.

There shall be a College Development Council for the proper planning and integrated development of Colleges and to provide assistance and guidance to serve as a vital link between the University Grants Commission, University Colleges, State Education Department and State Council for Higher Education.

The College Development Council shall consist of the following members:-

i. The Vice-Chancellor

- ii. Two members of the Academic Council to be nominated by the Vice-Chancellor.
- iii. One Syndicate member to be nominated by the Vice-Chancellor
- iv. Four teachers of the University, to be nominated by the Vice-Chancellor, from the following faculties not exceeding one teacher from each faculty:
 - a) Faculty of Arts
 - b) Faculty of Social Sciences
 - c) Faculty of pure Sciences
 - d) Faculty of pure Sciences
 - e) Faculty of applied Sciences
 - f) Faculty of Education
 - g) Faculty of Business Studies
 - h) Faculty of Law
- v. A representative of the Government to be nominated by the State Government.
- vi. Four Principals of Colleges within the jurisdiction of the University to be nominated by the Vice-Chancellor.
- vii. One Women Principal of the affiliated colleges to be nominated by the Vice-Chancellor.
- viii. Three teachers, other than Principals of College to be nominated by the Vice-Chancellor.

- x. Nominee of Karnataka State Council for Higher Education.

The total membership of the Council shall not exceed 20.

The term of office of the nominated members shall be three years.

- Any casual vacancy of a nominated member caused by death, resignation or the member ceasing to hold a particular office or a particular designation by virtue of which he become a member, shall be filled up by the Vice-Chancellor for the unexpired term.
 - The members shall be eligible for re-appointment not exceeding two terms.

The College Development Council may meet at regular intervals at least twice in an academic year, to review the implementation of various programmes and activities.

The College Development Council would serve as an academic guide to the college system on the one hand and on the other hand to ensure interaction between the academic faculty in the University departments and the teachers in the Colleges.

A minimum of seven members shall constitute quorum for a meeting of the Council. No quorum shall be necessary for the adjourned meeting.

The Vice-Chancellor shall preside over the meeting of the Council, and in his absence any member nominated by the Vice-Chancellor shall preside.

a) Appointment of Director, College Development Council

One vacant post of Professor or Associate Professor from any department of studies shall be redeployed for the purpose of appointment of Director. However, if a vacant post is not available, a supernumerary post may be created. There shall be a full-time Director to head the College Development Council. The incumbent teacher shall work as Director on Deputation for a specific term.

- ii) Scale of Pay:

 The Scale of pay shall be same as that of a professor of P.G. Department if a professor is appointed or that of an Associate Professor if an Associate professor

is appointed.

iii) Mode of Recruitment and tenure;

The Director shall be appointed with the approval of the Syndicate based on the recommendation of the Selection Committee consisting of the Vice-Chancellor as Chairman, nominee of Karnataka State Council for Higher Education Bangalore and a nominee of University Syndicate. The selection should be open and shall be done only from among the Professors and Associate Professors from P.G. Departments or Affiliated colleges. The appointment of the Director shall be on a tenure basis for a period of 3 years at a time extendable by another term. However, no person shall continue in the post beyond the age of superannuation.

iv) Qualification required:

- a) Any Teacher who has put in 5 years of service working in the cadre of Professor in the PG Department of the University or 10 years in the cadre of Associate Professor, either in the University or Constituent / Affiliated College is eligible to apply
- b) A person appointed as Director, College Development Council from amongst the persons in service shall continue to hold lien for all the benefits to which he is entitled.
- When the post of the Director of College Development Council falls vacant or when the Director is, by reason of illness or absence for any other cause, incapacitated from performing the duties of his office, such duties shall be performed for the period of not exceeding six months or until a new Director is appointed, whichever is earlier, by one appointed for the purpose by the Vice-Chancellor, with the concurrence of the Syndicate.
- d) The Director, College Development Council shall be solely responsible for the smooth and efficient functioning of the Council and shall implement all such recommendations of the College Development Council as accepted by the concerned authorities of the University.
- e) The Director, College Development Council shall as far as possible visit the colleges twice in a year to appraise them of the problems relating to the proposed development of colleges.

Functions of the Director of the College Development Council

The Director, College Development Council shall hold meeting of the College Principals with a view to apprising them of the way in which the College Development Council can function effectively for the development of the Colleges. The College Development

Council to attain this purpose in consultation with the University or other bodies concerned, take all such steps as may be expedient for the promotion, co-ordination and raising the standard of education in colleges and for the purpose of performing its functions. It may-

a) Function as a policy-making body in regard to proper planning and integrated

development of colleges.

b) Conduct surveys of all affiliated colleges, district wise with a view to preparing and maintaining an up to date profile of each college under the University, revising the existing facilities and identifying the needs and gaps that need to be filled for the development of colleges and make such information available to the UGC and other concerned bodies.

- c) Prepare a perspective plan for the development and opening of new colleges, to enable the University and State Education Authorities to take long term decisions on the planning and development of colleges and may advise the University on matters relating to different disciplines taught in colleges at different levels of University education;
- d) Advise the University on all matters relating to the development of affiliated colleges such as provision of adequate facilities-academic and physical for raising standards of learning, teaching and research and its periodic evaluation for enabling the University to maintain reasonable continuity of policy in regard to development of colleges;
- e) Advise the University in regard to rationalization and implementation of the University's policy for affiliation of colleges;
- f) Keep close association with the colleges with a view to helping them in their proper development, selection of teachers, students, amenities, proper utilization of grant and efficient implementation of UGC approved projects and reforms relating to Examinations courses, COSIP, COHSIP and restructuring of courses to make them more relevant and significant not only for students, but also for the region as a whole by assessing social transformation and regional development;
- g) Review the facilities for post-graduate departments of colleges in terms of the norms prescribed by the UGC and assist those having the potential of coming up to the norms within a few years;
- h) Help in the implementation of the Regulations framed by the UGC regarding minimum standards of instruction from UG level as also for restructuring of all courses.
- i) Help in the selective development of some colleges to remove regional imbalances and also assist the colleges to realize their potential and in the identification of colleges for autonomous status;

- j) Evaluate and assess the impact of UGC grants utilized by the Colleges for the implementation of various development projects;
- k) Ensure that the UGC grants released to the University for disbursement to the colleges are not locked up or utilized by the University for its own purpose, and also ensure that these grants are properly and expeditiously disbursed to colleges for specified purposes according to the guidelines laid down by the Commission;
- 1) Obtain from the colleges and furnish to the Commission utilization certificates and completion documents in respect of UGC grants released/disbursed to colleges through the university and help in monitoring the UGC programmes implemented by the affiliated colleges.
- m) Ensure close and continued contact and interaction between the academic faculties at the University teaching departments and at the colleges, monitor the development programmes and maintain regular statistics on the development of colleges;
- Review the inspection report of the colleges and suggest remedies for the defects and irregularities reported;
- To prepare the Annual Report of the functions of the College Development Council and submit to the Syndicate and the University Grants Commission.
- p) Perform such other functions as may be prescribed or as may be deemed necessary by the University for advancing the cause of Collegiate Education as may be incidental or conducive to the discharge of the said functions.

The Director, College Development Council shall be responsible to the Vice-Chancellor and send periodical reports to the University Grants Commission about the impact of UGC Programmes.
