have entered into an agreement on 11th Day of April 2019.

VSKU and **VVPL** are collectively referred to herein as 'Parties'.

Whereas VSKU is the Premier State Government University and a higher educational institution in Karnataka. VSKU Ballari is engaged in providing not only excellent science education but other educational disciplines through academic and holistic approach and is committed to value based education and human resource development. One of the main objectives of Department of Botany, VSKU is to promote utility and explore rare and highly medicinal and aromatic plants which contribute to the Ayurveda and Herbal medicine and to keep the society away from pharmaceutical hazards and to promote natural and herbal medicines. Added to this, it also aims at conservation, multiplication and bioprospection of wild and less known aromatic, edible and ethnobotanical plants of medicinal importance. VSKU shall explore the possibilities of offering training course for UG/PG students and staff in the areas of medicinal plants, herbal extracts, phytochemistry, plant taxonomy, pharmacognosy, invitro bioassays, biofertilizers.

Whereas VVPL has made substantial investments in conducting quality research in Nutraceutical /cosmeceuticals/ pharmaceutical discovery, development and manufacturing of drug from botanical sources, the creation of an extensive database on formulations used by traditional systems of medicine, a library of botanicals with information on their possible biological activity and a pattern recognition information of groups of chemicals believed to play a role in the biological activity of the botanicals; VVPL has at its disposal, experienced, scientific and technical staff and also possesses well-equipped facilities to conduct the necessary activities related to discovery and development of drugs/ nutraceuticals/ cosmeceuticals like hair promoters, hair removers etc.

Whereas both Parties hereto have agreed to jointly to discuss, develop and work on common areas of interest in Nutraceuticals, Cosmeceuticals, Pharmaceuticals/Herbal medicines that will help to establish a consistent backend support to VSKU's effort.

Being the topics of mutual interest as detailed below and develop Products under terms and conditions mutually agreed upon by both the Parties and shall promote active interaction among their staff and explore possibilities for undertaking commercial or public funded joint research and development projects.

Scientists of both institutions will be encouraged to apply for sponsored or funded projects keeping in view the interests and philosophies of the respective institutions.

Whereas the Parties desire, to record the broad terms and conditions that are jointly accepted and agreed to in this Agreement as contained hereunder.

1. DEFINITION

- 'Projects' shall be herein after referred to as a work on "plant based herbal extracts for therapeutic applications" the terms and conditions for execution of the project shall be as jointly agreed upon, in writing.
- VVPL's know-how' shall mean and include all know-how of methods, material, products, software, designs, patterns, formats, proprietary technical literature, and information developed, owned and provided by VVPL.
- VSKU's know-how' shall mean and include all know-how of methods, material, products, software, designs, patterns, formats, proprietary technical literature,

and information developed, published or otherwise owned and provided by VSKU.

- (d) 'VVPL's Personnel' shall mean the personnel or research and development engineers of the Company deputed for the Projects.
- (e) 'VSKU Personnel' shall mean the faculty members and / or scientists and / or students and / or staff of VSKU deputed for the Projects.
- (f) "Principal Investigator" shall mean the Scientist who shall be from VSKU, having the responsibility of conducting and supervising the Project(s) under this agreement, if it is VSKU Project.
- (g) "Co-Investigator" shall mean the individual(s) participating in the Project(s) under the supervision of Principal Investigator, including, but not limited to, students, employees, representatives, and agents.
- (h) 'Project Programme' shall mean the activities to be carried out as envisaged in this Agreement (**Willingness should be asked to VVPL before submitting the project proposal to third party/ funding agency**)

2. SCOPE OF AGREEMENT

VVPL and VSKU shall work jointly to carry out the Project with specific objectives, and terms & conditions jointly agreed under the Agreement.


3. OBJECTIVES:

3.1 Education :

- 3.1.1 VSKU and VVPL shall explore the possibilities of offering Industrial training course for UG/PG students and staff in the areas of industrial biotechnology.
- 3.1.2 VVPL shall impart teaching and training in related topics including pharmaceuticals, nutraceuticals and industrial biotechnology.

3.2 Research :

- 3.2.1 VSKU and VVPL shall promote active interaction among their staff and explore possibilities for undertaking commercial or public funded joint research and development projects.
- 3.2.2 Scientists of both institutions will be encouraged to apply for sponsored or funded projects keeping in view the interests and philosophies of the respective institutions.

3.3 Industrial training program

- 3.3.1 **VVPL** shall offer training courses of various durations to the students of **VSKU** using the company's infrastructure based in Bangalore.
- 3.3.2 **VSKU** shall encourage the students to avail the subsidized Industrial/company visit and workshop programs organized by **VVPL**.

4. **VVPL** shall provide Faculty Development Programs to the **VSKU** academic staffs on current trends in medicinal and aromatic plants and nutraceuticals. The training cost for all programs will be borne by the candidate(s) or delegates in a pre-determined manner.

5. Research Publications and Patents

- 5.1 Research findings as a result of this collaborative work between **VSKU** and **VVPL** shall be made available to the public after approval from both the parties.
- 5.2 Research findings published by either party will give credit to other party's contribution, but the party publishing them will be entirely responsible for conclusions and interpretations reported.
- 5.3 The right or proprietorship for any patents, products, technology development or other innovations, jointly developed by **VSKU** and **VVPL** shall be jointly owned as per agreement to be signed by both parties as case to case basis. Otherwise, both **VSKU** and **VVPL** agrees that any patents, products, technology development or other innovations produced by either **VSKU** and **VVPL** during the period of MoU, where there are no contributions from either **VSKU** and **VVPL** human resources, shall be the sole property of to the respective institution.

6. ASSIGNMENT

The Parties hereto shall not transfer or assign any of their rights and obligations under this Agreement to any other party / for any other purposes without obtaining prior consent in writing from other Parties hereto.

7. TERM / DURATION

The Agreement shall be valid for a period of **3** Years from the date of execution. The agreement may be renewed based on the performance and on mutually agreed terms and conditions.

The agreement may be terminated in the event of either party having breached the terms and conditions mentioned above. In such a case however the students already enrolled for the course or undergoing internship at **VVPL** shall continue and complete the course/internship as per the provision of this agreement for this purpose the agreement shall be operative. Either party can terminate the agreement giving 90 days notice.

8. TERMINATION

Any of the Parties may terminate this Agreement by serving a written 3 months prior notice to the other Party such termination by either of the parties shall not relieve that party of its obligations accrued prior to such termination, under a specific Project. Upon termination of this Agreement each Party shall return to the other party all Confidential Information and other material of the other party in its possession or custody.

9. NOTICE

All communications by **VSKU** involving financial, administrative and other matters shall be sent in writing to **VVPL**. All communications by **VVPL** involving financial, administrative and other matters shall be sent in writing to **VSKU**.

10. INTELLECTUAL PROPERTY RIGHTS

- (a) Title to all inventions, discoveries or developments made solely by **VSKU** inventors **prior to the signing of this agreement** shall reside in and be owned by **VSKU**;
- (b) Title to all inventions, discoveries and developments made solely by **VVPL** inventors **prior to the commencement of the Project** shall reside in and be owned by **VVPL**.
- (c) Any benefits accruing from assignment of Intellectual property rights to third parties will be shared between **VVPL** and **VSKU** under mutually agreed terms.

11. CONFIDENTIALITY

(a) It may be necessary for **VSKU** and **VVPL** to disclose to or exchange with each other proprietary information relating to **VSKU** know-how and **VVPL** know-how, which are confidential and proprietary. The disclosing party shall advise authorised personnel of the receiving party appropriately regarding the confidential nature of the information disclosed. The Party receiving such confidential or proprietary information shall not, unless specifically permitted in writing by the Party providing the said information, disclose in whole or part any such confidential or proprietary information or divulge any information thereon to any person other than its Personnel for fulfilling the purpose of this Agreement. The disclosure to any such Personnel as aforesaid, of any such confidential or proprietary information, shall be in confidence and only to the extent necessary for carrying out the obligations herein. Both the parties shall sign a separate Non Disclosure Agreement.

(b) The obligations of confidentiality however shall not apply to information that:

- is not disclosed in writing or reduced to writing and marked with appropriate confidentiality legend within thirty (30) days after disclosure;
- is already in the recipient party's possession at the time of disclosure;
- is or later becomes part of the public domain through no fault of the recipient party;
- is received from a third party having no obligations of confidentiality to the disclosing party;
- is independently developed by the recipient party; or
- is required by law or regulation to be disclosed.

12. ARBITRATION, APPLICABLE LAW AND JURISDICTION

(a) Any dispute arising with regard to any aspect of the Agreement shall be resolved by mutual discussions.

(b) If the dispute cannot be resolved by mutual discussions, the matter shall be resolved by arbitration in accordance with the Arbitration and Conciliation

Act, 1996. The venue of arbitration shall be Ballari. The decision of the arbitrator shall be final and binding on both parties.

(c) This agreement shall be governed by the Laws of India and subject to the jurisdiction of Courts in Ballari.

13. GENERAL

(a) Any addition, deletion and / or alteration to this Agreement may be effected with a written agreement of the Parties to this Agreement concerning the amendments. A document containing the additions, deletions and/or alterations, and signed by Parties hereto, shall form an annexure to and be deemed to be a part of this Agreement.

(c) The headings of various clauses herein are inserted for convenience of reference and are not deemed to affect the meaning or construction of relative provisions.

(d) This Agreement constitute the entire agreement among the Parties' and supersede all other representations, understandings or communication whether written or verbal, with respect to the subject matter hereof.
