ATUTE GOVERNING THE APPOINTMENT. POWERS AND FUNCTIONS OF THE RECTOR, STUDENTS WELFARE (SECTION 22) OF KARNATAKA STATE UNIVERSITIES ACT 100.

TITLE AND COMMENCEMENT

This statute shall be called "Vijayanagara Sri Krishnadevaraya University Statute governing the powers, functions and term of office and emoluments of the Director, Students Welfare".

This statute shall come into force from the date of assent by the Chancellor.

APPOINTMENT, TERM OF OFFICE AND EMOLUMENTS

The Syndicate shall submit a panel of three names of the rank of Professor / Associate Professor of the University/ Constituent Colleges to the Chancellor to select one and appoint him as a Director, Student Welfare, for a period not exceeding three years at a time.

A person thus appointed shall be entitled for a special pay of Rs. 1000/- p.m. in addition to his emoluments as Professor/Associate Professor of the University. 1)

POWERS AND FUNCTIONS

- 3. He shall be a whole time Officer of the University.
- He shall be a Member-Secretary of the Board of Students Welfare and convene the **i**) ii) meetings as per the direction of the Vice-Chancellor.
- He shall handle funds, fellowships and such other facilities meant for the welfare of students as per the rules/regulations and guidelines in vogue and be responsible iii) for maintenance of accounts and audit of such funds.
- He shall be the convener of such of those committees constituted for awards of iv) medals, prizes, scholarships etc for the welfare of students.
- He shall organize Seminars, Literary/Cultural Activities and such other programmes V) for the development of personality of the students.
- He shall visit the Constituent/Affiliated Colleges to look after the facilities provided for the welfare of the students and make suggestions to create necessary vi) infrastructure/facilities.
- He shall call a meeting of the Student Welfare Officers of the Affiliated/Constituent Colleges twice a year and ascertain the problems of the students and bring them vii) to the notice of the concerned authorities of the University and make efforts to solve the same.
- He shall have control over Chief Warden and Wardens of the University / College viii) hostels and take necessary action to provide required facilities in all the University hostels.
- Subject to the directions given by the Vice-Chancellor from time to time, he shall ix) supervise and maintain the discipline in the University hostels and campus.
- He shall exercise such other powers and perform such other functions as may be conferred or imposed on him by the Chancellor / Vice-Chancellor or by any other x)Statutes for the time being in force. 1
