- 1. I undertake that college shall impart teaching only in the subjects and for the courses/programmes for which affiliation has been specifically granted by the University. I understand that under no circumstances I shall seek retrospective affiliation. All such courses/programmes shall invariably be based on the syllabi approved by the appropriate academic bodies of the University.
- **2**. I bind myself to adhere to the provisions of the Karnataka Universities Act as amended up-to-date, the Statutes and the Ordinances, Rules and Regulations of the University stipulated in this behalf without committing any breach thereof.
- **3**. I agree to abide by the Rules, Regulations and Guidelines issued from time to time by the University and by any of statutory authorities.
- **4**. I understand further that the number of teaching posts, the qualification of teaching staff and their recruitment/ promotion shall mandatorily be as prescribed by the UGC. Their conditions of service shall be in consonance with the Statutes/Ordinance/ Regulations of the University/State Government/ UGC. I shall ensure adequate impartation of instructions to the students for the courses/programmes of studies which my college is required to provide. The Student-Teacher Ratio in my college shall be as per the UGC norms.
- **5**. I undertake to tender emoluments'/ salary to both teaching and non-teaching staff including applicable allowances regularly in conformity with

the pay scales prescribed by the UGC/ Central/State Govt. as the case may be, from time to time.

- **6.** I affirm that the appointment of teaching & non-teaching staff shall be based exclusively on merit & experience in conformity with the rules and regulations prescribed by the Government/UGC or any other statutory authorities and not by demanding and receiving any monetary or guided by any other extraneous consideration.
- **7**. I declare that the college shall obtain the eligibility approval in respect of the appointed teaching staff from the University positively within three months of affiliation. Any change in the teaching staff or such other changes likely to affect the fulfillment of the conditions for affiliation shall also be brought to the notice of the University in writing within a fortnight of the said changes coming into force.
- **8.** I state that fees to be chargeable from the students shall he as per the fee structure approved by the University based on the norms of the UGC from time to time.
- **9**. I declare that under no circumstances I shall collect any capitation fee or donation in any form whatsoever. I understand that collection of donation/capitation fees from students or their parents/guardians is is prohibited under law. I have no entitlement to collect any amount except the prescribed fees and other charges as approved by the University based on the norms stipulated by the UGC;
- **10**. I concede that I shall not under any circumstances admit any student to any programme of study in anticipation of grant of affiliation or in excess of the number of seats sanctioned per programme of Study.
- **11** I undertake that the college shall not, without the previous written permission of the University offer any programme of study or suspend an approved course of study/ programme.
- **12.** I bind myself to take care of the academic and welfare activities of the students belonging to the Scheduled Castes, Scheduled Tribes & depressed classed including minorities without fail.

13. I shall maintain all prescribed registers and records, including audited statement of accounts, as required under the Regulations / Orders of the UGC / University / Government and made available as and when asked during the course of inspection.

14. I undertake to furnish all such returns and other information as the UGC / University / Government may require for enabling it to monitor and judge the performance of the college with regard to maintenance of academic standards and shall take such action as the UGC / University / Government may direct in that behalf.
